- **4.** Performance Security shall be released after 12 months of the completion of work as recorded by Engineer-In-Charge.

- 7. The Bidder should have satisfactorily completed (not less than 90% of contract value), as a prime contractor (or as a nominated subcontractor duly approved by Employer, provided further that all other qualification criteria are satisfied) similar works during last seven years ending last day of month previous to the one in which bids are invited should be either of the following:
  - a) One similar completed work costing not less than the 80% value of the tendered cost equals to 13,77,768.00
  - b) Two similar completed works costing not less than the 60% value of the tendered cost equals to 10,33,326.00
  - c) Three similar completed works costing not less than the 40% value of the tendered cost equals to 6,88,884.00

(The Similar Works constitutes Renovation/Maintenance of Buildings)

- 8. Bidders may please note that they shall follow the safety and security procedures while executing the work. Bidder must follow all safety norms as per MoRTH specifications by installing signage, hoardings etc. for the safety of road users as well as for the safety of workmen working at site and any obligation on account of negligence in this regard shall be the responsibility of the contractor.
- **9.** Bidders may please note that the work should be executed as per the MoRT&H/CPWD specifications as applicable for the respective items. Necessary quality control tests shall be carried out as per the specifications and the decision of Engineer Incharge for acceptance of work shall be final Time is the essence of the contract and if the contractor fails to maintain the required progress or do not complete the work and clear the site on or before the expiry of stipulated contract period the contractor shall become liable to pay compensation at **Rs. 2000/-** per day subject to maximum of 10% of tendered value of work and the contract shall be liable for termination.
- **10.** The agency shall submit their bills along with the vouchers of the cement/bitumen purchased and consumed in the work along with the quality control results duly

certified by the representative of NHLML after the completion of work in duplicate and the payment will be released within 10 days from the receipt of bill.

- 11. The agency shall sign an agreement as per Form of Agreement (Annexure-A) and start the work within 7 days from the date of Letter of Acceptance and to be completed within 30 Days after start of work.
- 12. During the currency of the Contract, the Contractor and his sub-contractors shall abide at all times by all existing labour enactments and rules made there under, regulations notifications and bye laws of the State or Central Government or local authority and any other labour law (including rules), regulations, bye laws that may be notified already or that may be notified under any labour law in future either by the State or the Central Government or the local authority. All claims related to accident/damages/compensation shall be the responsibility of the contractor.
- 13. Amendments, corrigendum if any will be hosted in the office of the Zonal Officer, NHLML, Northern Region, Chandigarh.
- 14. NHLML reserve the right to cancel/reject/any or all bid at any stage without assigning any reason and no claim whatsoever nature will be entertained on this account.
- **15.** The rates considered in the BOQ are exclusive of GST and GST will be payable on submission of proof by the contractor and all other taxes (TDS, TDS under GST, Labour Cess) will be deducted as applicable.
