TERMS OF REFERENCE (TOR) OF TECHNICAL BID

Terms and Conditions

1. The vehicle to be provided shall be new or good in condition (vehicle manufactured after 01.01.2022 or not run more than 25000 Kms. till last date of submission of Bid 27.02.2023) and mechanically fit for smooth and safe transportation. In case the bidder proposed to provide new vehicle, the relevant documents shall be submitted before execution of agreement.

2. The bidder shall submit information as given in Technical Bid Annexure-I along with selfattested copies of documents supporting the information. In case the vehicle is not owned by bidder, a notarized contract agreement may be attached between the vehicle owner & bidder. If the bidder fails to provide vehicles as per Annexure-I&II, his bid shall be liable for rejection.

3. The vehicle should be in good running condition and well maintained preferably with top safety features like airbags, ABS, bumpers, fog lamps, parking lights, indicators, horn etc., suited for extensive running on high traffic density highways and Kachha roads. The successful bidder shall bear full responsibility for the safety of vehicle, its occupants and any third party and NHLMLs officials/representatives will be indemnified by the successful bidder on this account. Vehicle should be of top variant of its class/category.

4. All necessary taxes for operating the vehicle should be fully paid and all necessary papers shall be provided in the vehicle as required by prevailing Motor Vehicles Act with comprehensive insurance cover for the vehicle, its occupants and any other 3^{rd} party. Cost of insurance will be fully borne by Successful bidder and the rate quoted shall be inclusive of this.

5. The vehicle shall be provided day and night (24 hours) as required by NHLML for all days regularly in a month.

6. The vehicle shall also be used for outstation travel to other States/UTs. No extra payment shall be made to driver/owner on account of outstation travel/night halts. Agency shall also make available driver with adequate salary & DA (for outstation travel) having valid driving license with experience of running on Highways. The driver shall be well trained, physically & medically fit, well behaved, and suitably dressed in a defined dress code (summer & winter) approved by NHLML.

7. NHLML shall not be responsible for violation of traffic rules and/or infringement of any other law for the time being in force.

8. The successful bidder shall bear all expenses required for keeping the vehicles in smooth running condition such as fuel, lubrication oil & other consumables, necessary periodic service, repair & maintenance, driver & replacements etc. The rates quoted shall be inclusive of all these provisions.

9. The number of Vehicles to be engaged by NHLML may by increased or decreased on the discretion of NHLML. No compensation and rate revision shall be applicable due to increase or decrease in the deployment of vehicles.

10. The Bidder must quote the Rates both in words and figures for all category of vehicles. In case there is a difference between the quoted Rate in words and figures, the Rate Quoted in words shall prevail.

11. Penalties:

(A) In the event of any vehicle being rendered unfit for plying/service on account of maintenance, break down or for any other reason, the successful bidder shall provide a substitute vehicle immediately. If the substitute vehicle is not provided, a penalty of Rs. 3,500/- per day shall be affected from the bills of agency.

(B) The vehicle provided by successful bidder shall be kept clean externally and internally and in top working condition at all times failing which a penalty of Rs.500/- per day shall be affected from the bill of agency.

12. The vehicle shall be provided with name plate of NHLML if required, as approved by NHLML, on front and rear side of the vehicle. Vehicle shall be exclusively in the custody of NHLML for all the time & for all purposes.

13. The agency should quote their rates on monthly basis i.e. rupees per month. In case of excess km run by the vehicle in a month the payment of extra kms will only be considered on yearly basis and further adjusted at the end of the year or the time of closer of the agreement, if the average running during the period of agreement exceeds the specified kms. The year may be treated as Financial Year. However, the amount quoted for 4000 km for one vehicle & 3500 Km for second vehicle shall only be considered for evaluation of Financial Bid.

14. The vehicle provided should have permit to travel in All India (Specially in the State of J&K, Punjab, Haryana, Himachal Pradesh, Uttarakhand, Uttar Pradesh, Chandigarh, Delhi NCR & Ladakh).

15. The agency should ensure that sufficient fuel is always available for travel.

16. The agency shall ensure that the odometer of the vehicle supplied, is properly sealed so that no tempering is done to inflate kilometre distance travel.

17. No advance payment shall be made under any circumstances.

18. The quoted rates for hire charges per month include salary & other charges of driver, cost of all lubricants, maintenance, repair including cost of spares, toll tax if any etc & any other incidentals as may be required. The quoted rates shall be inclusive of all taxes & other charges applicable in the UT Chandigarh including entry tax. For running of vehicle in other states the applicable taxes of such states shall be paid by the firm and such amount shall be reimbursed to him on production of such vouchers during the payment of monthly bill.

19. No payment in addition to the quoted rates on any account whatsoever will be made /reimbursed unless it is specifically mentioned under these terms and conditions.

20. The GST will be reimbursed on submission of proof of payment only with necessary certification from CA Firm as required as per NHAI policy.

21. Either party may terminate the contract without showing any cause with one-month prior notice. <u>However, the services can be terminated by the NHLML, Zonal Office-Northern Region any</u>

time without prior notice. No claim of firm/ Party shall be entertained in such event.

22. The agency should submit their bills in duplicate along with logbook within 1stweek of every month for payment. It is the responsibility of bidder to maintain the log book for vehicle and get it certified from the concerned official using the vehicle, failing which, payment may not be made.

23. The quoted rates for the vehicles shall include fuel and lubricants, repairs and maintenance, Driver salary and other labour charges, depreciation etc and should be valid for a period of one year from the date of acceptance. No variation/revision in quoted rates for any reason will be entertained.

24. The successful bidder should be able to supply the required vehicles within 15 days or as directed by NHLML from the date of issue of 'Letter of Acceptance' by NHLML.

25. The supply of vehicles is initially for duration of one year only from the date of issue of Letter of Acceptance. In case NHLML, Zonal Office-Northern Region desires to delay the deployment of vehicle beyond 15 days of letter of acceptance, the duration of one year shall be counted from the date of providing the vehicle. The agreement may be extended beyond one year on mutual consent of both parties depending upon performance of travel agency and on recommendation of the concerned official up to maximum of three years.

26. The successful bidder shall submit all required documents of vehicle, driver, insurance, Road Tax, GST etc, to execute the agreement within a week of issue of 'Letter of Acceptance on a hundred rupee non judicial stamp paper, failing which 2^{nd} lowest bidder may be considered for award of tender at the lowest rate quoted in the bidding.

27. NHLML reserves full rights to curtail, modify, halt/cancel, reject any or all offer/s, at any stage without assigning any reasons and no claims of whatsoever nature will be entertained on this account.

28. Tender documentsshall be downloaded from NHAI website i.e. www.nhai.gov.in or NHLML website http://nhlm.in/ from 17:00 Hrs on **13.02.2023** to **27.02.2023** up to 15.00 Hrs during normal office hours.

29. Tender Cost

• The bidder shall submit **Non-Refundable fees of Rs. 500/-** (Rupees Five Hundred only) in the form of demand draft (issued by scheduled & nationalized bank of RBI) in the name of "**National Highways Logistics Management Limited**" payable **at Delhi.** In case the forms are downloaded from the website, the tender fee, as above, shall be submitted separately at the time of submission of bid.

• Any tender received without payment of tender fee shall be considered non-responsive and will be rejected summarily.

30. Earnest Money/Bid Security

The Bidders shall furnish, as part of the quotation Earnest Money/Bid Security of the amount of **Rs. 20,000/-** as specified in the document.

The Earnest Money shall be in the form of Demand Draft in favour of "**National Highways Logistics Management Limited**", **payable at Delhi**. Any Bid not accompanied by an acceptable Earnest Money shall be rejected by the NHAI as non-responsive. The Earnest Money of unsuccessful bidders will be returned within 02 (two) months. The Earnest Money of the successful Bidder shall be valid for **90 days** from the last date of submission of the Bid.

31. The Bid Security/Earnest Money will be forfeited.

- A. Any tender without Earnest Money/ Bid security shall be considered non-responsive.
- B. If the Bidder withdraws the Bid after its submission;
- C. If any Bidder does not accept any arithmetical correction of the bid price;
- D. In case a successful Bidder, fails to produce requisite documents to sign the Agreement and supply the vehicles within stipulated time after issue of 'Letter of Acceptance'.
- **32.** The last date for submission of sealed Tender documents at the "Address of Communication" is **27.02.2023** up to 15:00 Hrs and the same will be opened on **27.02.2023** at 15:30 Hrs. The Bidders may present during the bid opening, if they choose so.
- **33.** In case of any dispute, decision of the NHLML, Zonal Office-Northern Region shall be final and binding. Any further dispute shall come under the purview of High Court of Chandigarh.
- **34.** Bid shall be submitted at NHLML Zonal Office Northern Region in sealed envelopes including bid documents consisting duly signed quoted rates, terms and conditions; and undertaking. All the pages of Technical Bill and Terms of Reference (TOR) of Technical Bid are to be numbered and to be submitted in hard bound. Failure to submit all the requisite documents in prescribed format may result in rejection of Bid. The bids shall be accepted up to 15:00 hours on 27.02.2023 at following address.
