NOTICE INVITING TENDER

National Highways Logistics Management Limited (NHLML) (100% owned by National Highways Authority of India), Ministry of Road Transport & Highways requires accommodation of about 3000 Sq. ft for use as NHLML Guest House preferably in locations like nearby areas of Allahabad High Court, Medical Chauraha, Civil Lines/Cantonment, Circuit house etc in Prayagraj (UP) on monthly rental basis.
